This report covers the activities of the Florida Department of Veterans' Affairs (FDVA) for the Fourth Quarter of the 2016-2017 Fiscal Year.

1) Florida Department of Veterans' Affairs Administrative Highlights

a) Current Issues/Concerns

i. Executive Direction:

The Florida Senate unanimously confirmed retired Army Lt. Col. Glenn W. Sutphin Jr. as Executive Director of the Florida Department of Veterans' Affairs. The vote took place on May 5, 2017, during the 2017 Florida Legislative Session. Colonel Sutphin was appointed Executive Director by Gov. Rick Scott and the Cabinet during the Aug. 2, 2016 Cabinet Meeting.

Executive Director Sutphin accompanied Governor Scott to the signing ceremony of the Veterans Choice Program Extension and Improvement Act at the White House, held on April 19, 2017. The Bill further expands veterans' doctor and medical service location choices. Colonel Sutphin also attended agency mission essential meetings and participated in office calls with legislators and U.S. Department of Veterans Affairs leadership to discuss veteran issues relevant to Florida veterans.

ii. Division of Veterans' Benefits and Assistance:

(1) Bureau of Veterans' Claims Services:

The Bureau advocated for 20,961 veterans and their families, while 7,594 rating decision reviews of claims for disability benefits were completed through the Veterans Benefits Management System (VBMS). The VBMS is the U.S. Department of Veteran Affairs (VA) computer management system for claims processing.

During the Fourth Quarter, 345 veterans were represented before the VA Board of Veterans' Appeals (BVA) to uphold their appellate rights for veteran's benefits. Additionally, 81 personal hearings were scheduled with Decisional Review Officers at the St. Petersburg VA Regional Office. A great majority of appeals were mitigated prior to the hearing date, which was accomplished by FDVA staff offering highly skilled representation in advocating for the veterans. The actions also saved veterans from the often grueling travel and sometimes cost of lodging in order to attend their hearings. Impending Congressional changes to the VA appeals process, and VA development of processes to complete appeals quickly, efficiently and meet quality expectations, will present challenges to our staff in the upcoming quarter.

(2) Bureau of Veterans' Field Services:

Field Services' staff members David Austin, Ernie Kuykendall and Harry Rudy provided instruction at the Florida Department of Veterans' Affairs Certification Course held on June 5-8, 2017. The Bureau organized and facilitated the semiannual American Legion Post Service Office training on June 29-30, 2017, with more than 150 in attendance. The course covered various VA benefits, including: Disability Compensation, Pension, Health Care, Life Insurance, Education, State Veterans' Homes, State Veterans' Benefits, Burial, Waivers, Discharge Review/Military Records and the VA Home Loan Guaranty Program.

Together with the training courses and its normal workload, the staff was able to present, attend or otherwise support 186 outreach events providing earned benefit information to 10,322 veterans and their families and complete 9,692 disability claims. Field Services provided 80 production hours to support three Governor's Veterans Service Award ceremonies this quarter. Field Services' also assisted the Bureau of Claims Services by reviewing and entering 991 disability rating decisions.

(3) The Bureau of State Approving Agency (SAA) for Veterans' Education and Training:

Approximately 50,000 students received VA Education Benefits at more than 1,000 Florida schools and organizations approved to administer GI Bill® education programs. About 600 school officials attended training sessions performed by Florida's Bureau of State Approving Agency (SAA) at the annual Florida Association of Student Financial Aid Administrator's conference, annual Florida Association of Veterans Education Specialist's Non-College Degree School conference and at the 41st Annual Florida VA School Certifying Official Conference.

VA Education presentations were also delivered to those seeking County Veterans Service Officer certification and at FDVA's Fourth Annual State Women Veterans' Conference.

Attesting to the high quality of training offered by the Florida SAA, more than 50 School Certifying Officials from across the nation traveled to Florida for attendance at the SAA-led sessions at these conferences. The Florida SAA, known for their national leadership with flight school approvals and compliance training, boasts representation by Florida SAA Program Consultant Katherine Snyder. Snyder, who serves as Chair of the National Association of State Approving Agencies' Flight Committee, was honored with a Prudential Davis Productivity Award for her assistance with a Florida flight school and was also named as FDVA's Employee of the Year.

In addition, following a recent and successful site visit by the VA Central Office's Contract Team, VA representatives said, "The Florida SAA is a well-organized agency with excellent procedures and policies in place to ensure high quality service to the Florida veteran community. The team members are well-trained and proficient in their duties."

3) Veterans Florida

During the Fourth Quarter of Fiscal Year 2016-2017, Veterans Florida continued its work of implementing its statutory programs as well as continuing its efforts to assist veterans in finding and connecting with services and benefits.

a) Veterans Florida renewed its contract with Miles Media for Fiscal Year 2017-2018. During the fourth guarter Miles Media has produced videos highlighting Florida's diverse regions (North, Central and South). These videos are now linked to dedicated pages for each region, which will in turn highlight employers, resources and educational institutions in each region. http://www.veteransflorida.org/why-florida/live/

Veterans Florida also published a new education page on the Veterans Florida website, which provides visitors with the ability to gain information about colleges and universities throughout the state. The page is filterable by region, school type and amenities (i.e. on-campus housing, Veterans Resource Centers, etc.) Technical schools will be added in a later date. http://www.veteransflorida.org/veterans/education/

Veterans Florida also continues to grow its social media footprint and website traffic. At the conclusion of the fourth quarter, Veterans Florida has garnered 329,083 (+35,121 over compared to last quarter) website visitors, 75,164 (+79) Facebook likes, 12,813 (+2,923) newsletter subscribers, 403 (+63) LinkedIn followers and 267 (+20) Twitter followers.

b) Veterans Florida has decided to terminate its contract with Monster.com at the end of FY 2016-2017. A new Career Portal will be launched in July 2017, which will focus on the vacant jobs from our Veterans Florida Business Training Grant Employers. The new system will give Veterans Florida more ability to actively recruit for its registered employers as well as giving it better tracking capabilities to determine when veterans are hired by companies.

No new employer certifications were issued in June. The focus for the program this month has been preparing for the loss of our current grant manager and filling the open grant manager position, preparing for the new software transition, and recertifying existing program employers for the 2017-2018 fiscal cycle. Those recertified numbers will be available for the FY 2017-2018 First Quarter report. Additionally, we will receive this quarter's hiring/training reports from employers still under the original contract method, and provide those numbers in the next quarter report.

However, employers have continued hiring and training veterans.

Our businesses have reported 168 (+62 over compared to last quarter) veteran hires, with 114 (+30) of those hires having already completed their training. To date, Veterans Florida has reimbursed businesses \$471,787.34 (+\$126,097.65) for the training of veterans, generating \$6,918,054.20 (+\$2,566,631.80) in salaries.



c) The second year of the Veterans Florida Entrepreneurship Program began on Jan. 20. Veterans Florida received 458 applications for the 2017 program, and was able to enroll 300 veterans who attended classes at one of the seven Network Partner Colleges and Universities (University of West Florida, University of North Florida, Hillsborough Community College, Florida Gulf Coast University, Florida Agricultural and Mechanical University, University of Central Florida and Florida Atlantic University). Of the 300 that were enrolled, 267 attended the first day of classes. The program concluded on May 6 with 147 veterans graduating from the program. The program's graduation rate for FY 2016-2017 was 55%, which has improved 30% over the first year program.

The Board of Directors approved several important changes to the FY 2017-2018 Veterans Florida Entrepreneurship Program at the June 26 meeting.

The program will now consist of three distinct tiers, designed to serve veterans at different stages in their entrepreneurial development.

- Self-Paced Online Learning (to be launched in fall 2017)
- Stand Alone Workshops: Designed to be 2-3 hours in length, held periodically throughout the fall/winter of 2017.
- Advanced Class: Modified version of curriculum from past program, reserved for a smaller class size of well-vetted candidates with solid business ideas.

New contracts have been drafted and sent to the Network Partner institutions for signatures on June 30, 2017.

Executive staff and Board Members continued their engagement with external stakeholders including Momentum Solar, Sacred Heart Health System, Tallahassee Chamber of Commerce, Okaloosa County Economic Development Office, Florida Highway Patrol, Senior Life Insurance, Eglin Federal Credit Union, Jacksonville Auto Dealers Association, Lessar Corporation, the City of Tallahassee, Tallahassee Chapter of the Network of Entrepreneurs and Business Advocates (NEBA), Florida Chamber Foundation and Navy Federal Credit Union.





4) Florida Veterans Foundation (FVF)

The FVF serves Florida veterans and their families by providing direct services in partnership with a spectrum of other organizations including state and local governments, other veteran service organizations, and educational institutions to improve our veterans' physical, financial, mental, emotional and social well-being. The FVF supports the Florida Department of Veterans' Affairs mission of advocacy by educating the public and governmental entities to increase awareness of veteran-related issues.

The Fourth Quarter of Fiscal Year 2016-2017 continues with the many challenges of fundraising that nonprofits are experiencing, especially with competing veteran entities within the state and nation. The new world of nonprofits is how to stay in business, while keeping pace with the mission. The new prospective is that you are relying on grant dollars, state, federal and private monies for support. Nonprofits may dissolve if they solely rely on that funding. The "new" for nonprofits, like FVF, is to create a business model that brand, market and outsell their competitors. In other words, "entrepreneurial" is the name of the game. It's only been through a grant from Attorney General Pam Bondi that has allowed the Foundation to continue operating. During the fourth quarter beginning April 1, 2017 and ending June 30, 2017, the FVF provided emergency financial assistance to 165 Florida veterans, expending funds of \$79,462.

The FVF leadership has been working hard to garner whatever avenues are available for resources to sustain the operation. We have been innovative in seeking talented individuals through recruitment of interns from local colleges as well as student veterans to help us serve veterans. The push to find these resources save the foundation dollars as they are either gaining credit toward college rather than money and that student veterans in a work study status are being paid by the U.S. Department of Veterans Affairs. A further hustle in the attempt to preserve precious dollars has been the hiring of senior workers who are paid by AARP. The Senior Worker Program employs older personnel in attempt to reintegrate them into the workforce while gaining tools of workplace.

The FVF recently became aware of high dollar initiatives that are directed toward post-9/11 veterans. One is the Wounded Warrior Project (WWP), who direct all their support to post-9/11 veterans and severely wounded. The FVF is listed as a resource for emergency financial assistance on the WWP website for all veterans not included in their demographic of veteran. Additionally, the Wayne Weaver Foundation has given \$1 million to the American Red Cross for Baker, Clay, Duval, Nassau and St. Johns Counties for the emergency financial assistance of veterans. However, to be eligible you have to be post-9/11. This is important because there is a contingent of about 80% of "other" veterans who are not supported by their efforts. The FVF spoke with the WWP CEO, and asked about the opportunity for a grant from WWP. He said that it had been a bad year so there were no funds available for FVF to receive a grant from them.

The FVF continues to increase awareness on social media and has created a Twitter account to top off the aggressive reach throughout the state. For this quarter, the FVF has received 11,306



Facebook page views. We have begun a new campaign; the One Less Latte challenge, which solicits donors through an appeal to think about helping veterans in lieu of a latte. The business cards handed out direct the recipient to the FVF website and asks for a recurring donation of five dollars or more to sustain the Emergency Financial Assistance Program. For this quarter, FVF has reached 15,199 potential donors via webmail.

Leadership has taken the fight for funds to statewide organizations, e.g. the Florida Independent Funeral Directors. At their recent conference, the FVF requested their board reach out to the more than 800 Independent Funeral Home Directors to offer families of deceased veterans an avenue to donate to the FVF in lieu of flowers as a way to honor their veteran. We found that there was an increase in donations through this initiative.

The second effort for funds was by way of creating a dialogue with the Florida Association of Counties and a letter request from the Foundation to leadership of every county in the state. The request was for a \$10,000 donation from each county to FVF so that their veterans could receive emergency financial assistance. No counties have donated to date. Ironically, one county declined one day prior to opening a new veteran resource center, which is funded to operate by the county. A day after opening this resource center, the Foundation received a call from a veteran of that county seeking emergency financial assistance. For 2016, the county received more than \$33,000 for their veterans from the FVF, but has set aside that money to operate the facility. The FVF assisted the veteran.

Currently, Leon County has a high functioning Veteran Emergency Assistance program and has provided funding through the Foundation to expedite claims processing. Leon County provided over \$70,000 in calendar year 2016 for the relief of veterans. In addition to the funds allocated by the county, the Foundation has supplemented the needs. This particular county has the most wellknown program thus enticing more veterans for assistance. The state would be well-served to do a needs-analysis on veterans and to see what opportunities for support exist beyond the foundation.

As highlighted on the Third Quarter report, FVF has produced four marketing videos. These videos were produced free of charge through Ron Seggi. He wrote and directed four videos utilizing his videographer in Orlando. The focus was to re-introduce the mission of the Foundation to every Floridian while highlighting the work that is being done to provide comfort and relief to veterans in need. Maj. John Haynes, Chairman Mike Mason and Martine Caraballo were the subjects of the videos. These videos were sited on the FVF Webpage, Facebook and uploaded to the FDVA YouTube site.

The FVF has teamed with Florida HR to become the recipient of proceeds from their upcoming August 2017 conference. The Florida HR group will host more than 1,500 HR professionals from all over the state. In addition, there will be veteran representation from every county and representation from the Pulse Club first responders. It will be incumbent upon the Foundation to promote the event and evoke the greatest donation possible.

At the end of the third quarter, FVF requested the current AG Grant to extend into a third year. Currently there are enough operational funds to finish the 2017-2018 Fiscal Year with \$10K in reserve. The FVF has taken the lead with the Florida Veterans Council to develop a "Top Five" priority for the FDVA to support the next legislative session. These should be available on July 13 at the next Florida Veterans Council meeting.

- A priority would be a Legislative Budget Request on behalf of the FDVA.
- To gain sponsorship for a scratch off lotto ticket as a means of raising funds for Florida veterans.



- The Foundation is to seek a special appropriation for construction of the Florida Veterans Memorial so that it may be completed.
- The Capitol renovation project is working in the House side to ensure loading of the ground above the House parking garage.

Each month the FVF continues to experience an increase in the number of veterans requesting and receiving services. The widespread and aggressive marketing efforts have illuminated our existence and the HELP Grant that provides the financial wherewithal to assist veterans facing emergencies. These results are reflective of collaborative efforts on the part of service providers who target veterans living throughout the State of Florida through various mediums (electronic, face-to-face, print, etc.), social media, statewide advertising, Stand Downs, conferences, and other activities.

a) Veterans Served

The goal of the grant is to reach approximately 329,000 veterans during the first year of the grant, or 82,263 per guarter. For the fourth guarter ending June 30, 2017, the grant touched the lives of 150,648 veterans through distribution of the Florida Veterans' Benefits Guide and other FVF outreach efforts. FVF's marketing efforts will continue to target our efforts of providing services in all of the areas and to assist veterans throughout the state, districts and counties.

Based on the expenditures for the fourth quarter, the greatest need is assistance in the Housing category: a total of \$79,462.18 has been spent during the quarter to prevent eviction and homelessness. The actual expenditures document where the greatest needs currently exist and will be used as needed to reallocate funds between the areas of service originally proposed in the agreement. Continuously throughout the fourth quarter, the Foundation received requests for financial assistance caused by unforeseen circumstances (e.g., joblessness, family crisis, disabilities, holiday expenditures, climatic conditions, unexpected or chronic health problems, and etcetera) that created financial hardships for veterans and their families. Our core mission is to provide emergency assistance to prevent veterans from being homeless or being at risk of becoming homeless. The reality being that veterans need the financial assistance because the above-mentioned variables are constant in their lives throughout the state.

b) Other Initiatives

North Florida Stand Down 2017 was held at the North Florida Fairgrounds on April 21 – 22, 2017 and served 320 homeless and/or at-risk veterans; the majority were at-risk veterans. The event was successful due to the collaborative efforts of all parties involved. There were 52 vendors/service providers (more than 200 persons who provided those services) and 130 volunteers that assisted in this endeavor. The monetary donations exceeded \$42,000 and the in-kind donations exceeded \$40,000. We are appreciative of all those businesses that generously gave us help to defray the cost of hosting the Stand Down for our veterans. Overall, we were able to heighten the awareness of FVF and provide many needed services to our honored veterans. The funds are not available for FVF to remunerate someone to manage a Stand Down. The Foundation provides \$2,500 to each county hosting a veterans' Stand Down.

c) Florida Veteran Foundation Funding and Fundraising

The Foundation's reputation as the beacon of hope to veterans in need of emergency financial assistance has been established. The ever increasing and irreversible need for available funds to provide financial assistance to Florida veterans is growing without signs of slowing down. Sponsorships and fundraising opportunities have being explored and developed for the



continuance of funds for the FVF to remain viable to provide emergency financial assistance to Florida veterans.

The FVF is working diligently with the FDVA Legislative Affairs Director to seek funding by the state to be in place prior to the end of the AG HELP Grant. Without state funding, the enormity of the financial impact on the lives of veterans throughout the State of Florida would be critical. Veterans faced with a financial crisis have come to depend on the Foundation as a last resort for financial assistance and to provide relief in their moment of despair. This is the top priority for the Foundation. FVF is increasingly becoming more engaged with legislators and opportunities for future and recurring funding. This is the number one priority and will remain so as long as there is a need to provide relief for those who have served us so well.
