### HB 7073 Taxation by Ways & Means Committee

Taxation: Providing that a taxpayer has a right to know certain information regarding property determined not to have been entitled to a homestead exemption; requiring that the owner be given a specified timeframe to pay certain taxes, penalties, and interest prior to a lien being filed; providing that such lien is subject to certain provisions; prohibiting the taxpayer from being assessed certain penalties

or interest under certain circumstances; providing that back taxes apply only under certain circumstances, etc. Effective Date: July 1, 2024

Compensation for Advising or Assisting in Veterans' Benefits: Provides short title; provides purpose; prohibits person from receiving compensation for preparation, presentation, or prosecution of claim or advising or assisting individual with regard to veterans' benefits matter except as authorized by federal law; prohibits person from receiving compensation for referring individual to another person for such services; requires person who receives compensation for such services to be held to certain standards in rules regulating The Florida Bar; provides that violation is deceptive & unfair trade practice.
